

# Southern California Plaster Tenders Joint Apprenticeship Committee

## **REQUEST TO INDENTURE EXPERIENCED JOURNEYPERSON**

Contractors signatory to the Plaster Tenders' Master Agreement may request/sponsor an experienced Journeyman (as defined by the Joint Apprenticeship Committee), with a minimum of 4,000 hours, by completing this Request to Indenture form and a sponsorship letter on Company letterhead. This form and your letter will be submitted to the Local Union for review.

Upon approval, the Journeyman applicant will be reviewed by the Joint Apprenticeship Committee. The Joint Apprenticeship Committee, in compliance with the regulations of the California Apprenticeship Council, may grant credit in the Apprenticeship Program based on the Journeyman's work history and experience, training, education, certifications, and his/her mastery of the skills and knowledge of the in the work performed by this craft. A Journeyman who is granted the maximum credit based on these factors will be slotted into the fourth period of the Apprenticeship Program, provided that the Journeyman must complete not less than six months as an Apprentice including forty (40) hours of Related and Supplemental Instruction. Please note that applicants who have worked between 4,000 and 9,999 hours in the industry will require the review and approval of the Joint Apprenticeship Committee to enter the program. Applicants with 10,000 or more hours will be accepted without prior approval of the Joint Apprenticeship Committee.

Once the Journeyman is accepted in the Apprenticeship Program, this person is a State registered Apprentice while in the Program, including for purposes of public works projects and reporting on certified payroll records. **However, please note that the Plaster Tenders' Master Agreement has been amended to provide that the Contractor must continue to pay the Journeyman wage and fringe benefit package on behalf of this Apprentice.**

It is the responsibility of the Contractor to ensure proper dispatch of the Apprentice by the Local Union. By signing below, you agree to employ the sponsored Apprentice for a minimum of six months.
